REGULAR MEETING

February 29, 2016

Monday – 6:30 p.m.

The Board met in regular session on Monday, February 29, 2016, at 6:30 p.m. Trustees present were: Chair Paul Finnicum, Cheryl Kirkaldie, Gy Salvevold, and Ron Larsen. Representatives were: Larry Crowder, Mike Olson, Dave Solem, and Lora Finnicum. Visitors were recognized. Notice for public comment given.

Ron Larsen made motion to approve the minutes of January 19<sup>th</sup> (athletic committee), January 19<sup>th</sup> (regular board), February 8<sup>th</sup> (special board), February 15<sup>th</sup> (negotiations committee), and February 23, 2016 (special board) meeting(s). Cheryl Kirkaldie seconded motion. Motion carries unanimously.

Reports were given. Newly elected student council members were announced. JH students have requested to form their own council and advisor. Student Council constitution and by-laws were presented. 




